Provincial By-Law \#11(b): In each Provincial voting Area there shall be allocated one (1) Councillor for every approximately 40 members in good standing plus an additional four (4) Councillors to the district of Provincial Headquarters.
Provincial By-law \#11(e): That for the purpose of establishing the number of Provincial Councillors per District, the President will be named as one of the additional four Councillors allocated to the District of Provincial Headquarters, regardless of the location of her primary chapter.
Provincial By-law \#16: That a nominee for Provincial and/or National Councillor shall stand for election in the designated area in which active membership is held, except for a nominee from a chapter already under Municipal jurisdiction. Such nominees shall stand for election in the area in which that Municipal Chapter is located.
